Kindergarten-8th grade tuition covers only a portion of the cost to educate your child. The current cost to educate each child is approximately \$8195. The difference between the tuition and the cost to educate is covered through the parish and fundraising activities. This means that through the generous support of our community, all families receive a subsidy of a minimum of \$1710 up to a maximum of \$13,775

 - 3) Two Payments by July 1 and December 1, 2022.
- The multi child discount is not applicable to the preschool program
- Families choosing to utilize the FACTS program must annually fill out a pre-printed form and provide a voided check.
- Any family in arrears for the current year will be delayed registration. If financial difficulty arises during the year, please schedule an appointment with Msgr. Gardin so that continued attendance may be arranged.
- If space is not available for preschool, a waiting list will be used.

If space is limited, preference will be given to families in the following order and *according to date of submission*:

- 1) to families with children currently in school, CURRENT FAMILIES MUST RETURN THE REGISTRATION FORM NO LATER THAN FRIDAY, JANUARY 15 TO SECURE THEIR SPOTS. (WE ARE ANTICIPATING FILLED CLASSROOMS IN MULTIPLE GRADES.)
- 2) families new to Immacolata by date of registration already placed on the waitlist
- 3) all other new families
- Class size will follow Missouri state standards.
- To secure your registration, there is a \$365 registration fee per child. This fee covers preschool snacks, our growing technology program, textbooks, materials and includes the annual Home & School Association fee. The annual Home & School Association fee goes toward the cost of holiday parties, speakers & activities, etc. \$65.00 per student.
- A minimum of half of the fee (\$182.50 per child) for each child is required by *Friday, March 5, 2022 or time of registration*.
- If paying half in February, the rest of the \$365 fee per child is due by Friday, May 7, 2022.
- Checks should be made payable to Immacolata.
- ***Registration will be refunded only in the event that a family moves from the area.

- The cost to educate one child during the current 2021-2022 year is \$8195. Tuition only covers a portion of the expenses. To keep the cost of Catholic education affordable for families, multiple children from the same family pay a declining percentage of the one-child tuition rate. This means the tuition covered by the parish ranges from \$1,710 to \$13,775 depending on the number of students per family and if in or out of the parish. This amount covered by the parish is paid through fundraising (auction) and parish support (Sunday collection and donations). This does not include students receiving parish-based scholarships.
- There are three payment options:
 - 1) 11 monthly payments withdrawn from your checking account using the FACTS collection system, July 2022-May 2023.
 - 2) Single payment of the entire annual tuition by July 1, 2022.
 - 3) Two Payments by July 1 and December 1, 2022.
- Families choosing to utilize the FACTS program must annually fill out a pre-printed form and provide a voided check.
- Any family in arrears for the current year will be delayed registration. If financial difficulty arises during the year, please schedule an appointment with Msgr. Gardin so that continued attendance may be arranged. No child from the Immacolata Parish will be denied attendance due to financial reasons. Scholarships are available through the Diocese and the Parish.
- If space is not available in a grade, a waiting list will be used.
- If space in a grade is limited, preference will be given to families in the following order:
 - 1) to families with children currently in school,
 - 2) families previously placed on waitlist
 - 3) open for remaining spots
- Class size will follow the enrollment policy as previously established.
- To secure your registration, there is a \$365 registration fee per child. This fee covers our growing technology program, textbooks, materials and includes the annual Home & School Association fee. The annual Home & School Association fee goes toward the cost of holiday parties, speakers, fieldtrips and bus transportation, etc. \$65.00 per student.
- A minimum of half of the fee (\$182.50 per child) for each child is required by *Friday, March* 5, 2022.
- If paying half in February, the rest of the \$345 fee per child is due by Friday, May 7, 2022.
- Checks should be made payable to Immacolata.
- Registration will be refunded only in the event space in a grade is unavailable or a family moves from the area.
